If you missed EHS's CCP Information Meeting but are interested in taking college credit plus courses in the 2024-2025 school year, there are two more information nights available. All students must follow the checklist and meet the required deadlines, or they will not be permitted to participate in the CCP program.

SCHEDULING for the 2024-2025 School Year

Scheduling at EHS is underway. Information is available on the EHS website. Here are things to consider when picking out courses for next year:

Are you on track for graduation? Are you thinking about attending A-Tech? - If you have submitted an application to A-Tech, you must still submit a course selection sheet. Are you thinking about doing College Credit Plus? - The deadline to submit your letter of intent for CCP is April 1st! Rising seniors must have at least 5 credits; you can have early release (7th & 8th or just 8th) or late arrival (1st and 2nd or just 1st). Rising juniors must have at least 6 credits; you can have early release (8th only) or late arrival (1st only). Rising sophomores and freshmen must have at least 6 credits and there is no early release or late arrival option. Counselors are available to discuss your questions or selections. Please sign up through the google form.

The FAFSA Application is now open!! The priority deadline for many schools will be February 15, 2024 but it is best to double check with the school you are applying to for more specific information. Some schools have extended their initial deadline to March 1, 2024.

HALFWAY THROUGH SENIOR YEAR

The first semester is now history and hopefully you have successfully achieved your goals for the first half of your senior year. As the final semester of your high school experience begins, your education/career plans following graduation should become more concrete. The Guidance Department is ready and willing to help should you need assistance during the critical decision-making period.

Any senior who receives a scholarship or award should provide a copy of the award letter to Mrs. Rapose in Guidance. We keep an up-to-date record of scholarships and awards won by the members of the senior class.

TIPS FOR BORROWING MONEY FOR COLLEGE

- 1. Learn the language. Sort out terms and definitions.
- 2. Evaluate how much you really need to borrow.
- 3. Evaluate how much you will be able to repay.
- 4. Shop around. Student loans subsidized by the government tend to have lower interest rates and deferred payment provisions; parts of some loans may be "forgiven" if you perform certain kinds of work or service after graduation.
- 5. Know the full facts before you commit yourself: What is the interest rate of the loan? Date payment begins? How long will it take to pay off?

DON'T GET SCAMMED ON YOUR WAY TO COLLEGE

Look for six signs that a scholarship search may be a scholarship scam:

- 1. "This scholarship is guaranteed or your money back." No one can guarantee that they will get you a grant or scholarship. Refund guarantees often have conditions or strings attached. Get refund policies in writing before you pay.
- 2. "You can't get this information anywhere else." There are many free lists of scholarships available. Check with your school or library before you decide to pay someone to do the work for you.
- 3. "May I have your credit card or bank account number to hold this scholarship?" Don't give out your credit card or bank account number on the phone without getting information in writing first. It may be a setup for an unauthorized withdrawal from your account.
- 4. "We will do all the work." Don't be fooled. There is no way around it. You must apply for scholarships or grants yourself.
- 5. "The scholarship will cost some money." Don't pay anyone who claims to be "holding" a scholarship or grant for you. Free money shouldn't cost a thing.
- "You've been selected by a national foundation to receive a scholarship" or "You are a finalist in a contest." (a contest you never entered) Before you send money to apply for a scholarship, check it out. Make sure the foundation or program is legitimate.

<u>SCOIR</u>

All EHS and A-tech students have been invited to create an account in SCOIR. SCOIR is the one-stop online system that provides students with college and career planning tools. In SCOIR, students can request transcripts and letters of recommendation, and register for upcoming college visits at EHS.

COLLEGE ENTRANCE TESTS

There are two college entrance tests – the **SAT** and the **ACT**. Check the colleges of your choice to learn which test is required. Register for these tests on the web.

If you are a junior or senior and participate in Free/Reduced Lunch, your school counselor can give you a fee waiver to cover the cost of the test - including late fees. Also, by using a fee waiver you will receive additional access to test prep materials for free. Please do not wait until the last day to register to request a fee waiver because the school counselors may not be available.
